
experiences were different in a lot of ways too. We filmed their conversation and will use some of it in a video.

We need to take photos of members using public transport.




We also need photos of the things that members do in their day to day life and at home.

The UK Government are reviewing the Human Rights Act in the United Kingdom.

They want to replace the Human Rights laws. They want to change them from the ones we had in Europe to ones that are British.

This is because we left Europe after Brexit. Human rights organisations like the British Institute of Human Rights (BIHR) and Liberty are very worried about this.

They believe that changes to the Human Rights Act will mean everyone in the United Kingdom will have their rights weakened. This means that disabled people could be very vulnerable.

We need Human Rights laws to keep us safe And to make things fair.

If Human Rights laws aren't strong enough it makes it much easier for a Government to do things that may not be fair.


And much harder for us to challenge them. Because the actions they take, will be lawful.

One of the worries we have is that this is being spoken about in the House of Commons and most people don't know about it.



The UK Government have put out a consultation to get the views of the people of the UK.







A lack of Easy Read information discriminates against people with learning disabilities.

The BIHR ran an Easy Read event online on the **8th February 2022**.

We shared the link with groups and on social media.

We need to make our voice heard.

Whether we think the new rights are better or worse it is important that people have a chance to decide for themselves.


To have a say.

And on social media.


We want to encourage as many people and organisations as possible to fill in a consultation form.



Work has been done in Anglesey on work opportunities, and we are looking forward to our views been heard and getting real jobs in the community.





Vale People First - By Mark Tierney
Hi, I'm Mark and I am the new Vale People
First Covid Safety Officer. We got funding
from the Big Lottery Awards for All Wales for
my job. I also have a PA called Jo.
I started my job on 4th November and I work
for 6 hours per week.



The first thing I did was to have training all about Covid-19 and the rules. This helped me to know exactly what to do to help to keep our members safe when we are doing activities.



Me and Jo also had a meeting where we discussed what PPE we needed to order. I designed my new uniform so that people know where to come for advice. Here is a picture of me in my Hi-Viz and matching orange tops.



I did my very first meeting at our fundraiser at Romilly Park. I had my PPE and forms to ask people for their names and phone numbers. I took the temperature of every person that attended and offered hand sanitiser to






everyone.

Our next meeting was an indoor event at The Wellbean Café. I made sure that I was there to set up before everyone else and greeted them as they came in. Again, I asked for contact details and took people's temperatures. I also reminded people that they needed to wear their masks when they were moving around the café but could take them off when they were sat down.




We have a weekly meeting on a Monday to plan the week and I have worked at several events now to keep all the members as safe as possible. I am also doing regular refresher training to make sure that I am up to date with all of Welsh Government Covid regulations.



I also did a presentation at the Learning Disability Wales Conference this year, I presented to 131 people, to tell them about my job and how important it is for me to have paid employment. It has boosted my confidence and it is a big step up from volunteering for me.







The Caerphilly People First Reconnect Focus group has continued to meet weekly. Our recent activities include: a recap from Digital Communities on how to keep safe online and not fall prey to scammers; group discussion on coping through the pandemic; working on digital skills; taking part in filming by the Welsh Ambulance Service.



We recently connected to Conwy Connect's Health Check Workshop. We learned what a health check is and how important it is that people have one every year. You can book your annual health check by calling your GP. The health champions who ran the workshop did a fantastic job and the event was very informative and fun.





#### **West Glamorgan People First**

Our membership is growing and we now have more groups meeting than ever. Members have begun to meet face to face but Zoom groups will continue as long as people are worried about catching Covid 19. These are our groups and you can find out more on our website

Funky Zoom Night Club; Talk Tuesday; Arts and Crafts; Ponty Friends; Snack and Chat; Karaoke; Advocacy Group; Film Club; Talk Sport; Saturday Social with Kelsey and Lily.



Right through the pandemic, the groups have been a lifeline for members who may have felt lonely and frightened. People have been able to get together and share interests and experiences.



Now that there's light at the end of the tunnel, some members have been keen to get out. A recent highlight was our Halloween sponsored walk in Penllergare Woods attended by around 20 people. We were welcomed by Penllergare Trust who look after the woods. Members walked three miles (in fancy dress!). So far we have raised over



£300 in sponsorship.

Members have told us that they struggle to get transport to some events. Most often they can't get a bus home in the evening. We are trying to raise money to recruit volunteer drivers, pay for taxis and even get our own mini-bus so that no one misses out on the chance to socialise with friends.



Lloyds Bank Foundation are supporting us to build a bigger, better People First. They have given us money and their experts are helping us to plan for the future. We intend to make WGPF an organisation led by its members, but this takes time.



We also continue to work with Swansea and Neath Port Talbot Councils. They agree that people with a learning disability should have more say about what the Councils do and what services they deliver. We have helped them and the Health Board to re-write their information in easy-read, so that more people can understand it.

Attended the first meeting of the re established Cross Party Group on Disability this morning. Mark Isherwood MS was re-elected as Chair and Megan Thomas and Disability Wales were elected as the secretariat. Respect to Learning Disability Wales who had previously taken on the secretariat on an interim basis. Their involvement meant the group could still take place.

The most important thing we discussed was the Locked Out report, which reported the experiences of disabled people throughout the pandemic. I made a plea for opposition parties to ensure they scrutinise and hold Welsh Government to account in the Senedd over progress made. I was disappointed with the lack of interest the opposition parties showed towards the Locked Out report when it was first released, with the exception of course of stalwarts such as Mark Isherwood MS who has always been a positive champion of the rights of disabled people
