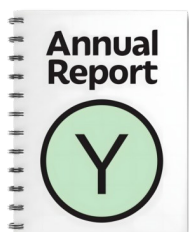

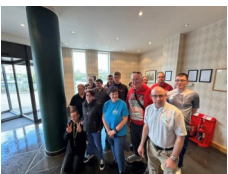

- To change the maximum amount of board members of All Wales People First from 15 to 10.

## 5

## **Minutes of the Annual General Meeting held on the 25<sup>th</sup> June 2025, at Kinspa and Kinmel Hotel, Abergele**

### **Who was at the meeting:**

Lucy Hinksman (Chair, National Council)

43 full members were present.

The meeting was quorate.

An organisation's rules say how many people need to be at meetings. This number is called quorum. If there are enough people, the meeting is quorate.

**Welcome:** Lucy welcomed everyone to the meeting. She said that copies of the Annual Report and the AGM pack had been given out already.



1. **Apologies:** There were no apologies for absence.



2. **Minutes of the Annual General Meeting held on 20th June 2024:** The minutes were approved and there were no questions or matters arising.

3. **2024/25 Annual Report Highlights:** the Chief Executive covered the most important highlights from the annual report. These included

- Funding from Welsh Government
- Benefit cuts
- Homes not Hospitals
- Advocacy Strategy
- Trading Arm



There were no questions.



4. **Finance Report:** the Business and Finance Manager Victoria Sidwell Brown presented the financial report.

- Fran Holmes asked whether staff got travel expenses and Victoria said yes.
- Kamar Elhoziel said that AWPf had done well to keep under budget and to prioritise important work.
- Becky King asked whether the finance report related to one year and Vicky confirmed this.



5. **Adopting the Annual Report:** members voted to adopt the annual report. (29 members present voted in favour)



6. **Retirement from Board:** according to AWPf rules, one third of the board members must retire each year. They can ask to be re-elected. This year, Bob Rhodes and Michael Allcock had to stand down. They both wanted to be re-elected. Members voted and they were re-elected. (Bob Rhodes – 21 votes; Michael Allcock – 28 votes) The Chair congratulated Bob and Michael on their re-election.
